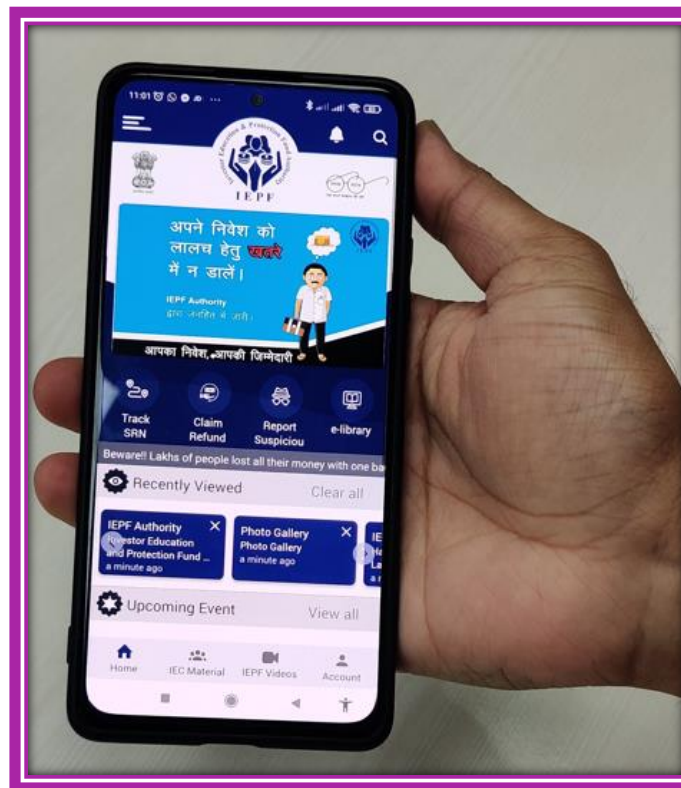




Glimpse of AVs developed by NFDC as TVCs on Various Channels & Digital Modes


